MASTER OF ARTS IN ART EDUCATION

Overview

The Master of Arts in Art Education from The Art of Education University is an accredited, 36-credit, 100% online master's degree program. This affordable, flexible program is designed for practicing art teachers. Through this program, teachers will expand their understanding of the field, conduct valuable research, and engage in personalized, meaningful study directly applicable to the classroom. Most students in the Master of Arts in Art Education program will complete the program in two years.

Program Outcomes

Program outcomes for the Master of Arts in Art Education engage students as they:

- Produce advanced professional education curriculum for the K-12 classroom using art pedagogy and best practices.
- Evaluate and plan assessment strategies that authentically measure student engagement and teacher effectiveness.
- Design classroom management strategies using methods specific to the art room.
- Reconstruct art-specific content and delivery using educational methodologies, learner theories, and new mediums to reach the contemporary art student.
- Generate leadership and advocacy skills while shaping a professional mission.
- Conduct meaningful and valuable research in the field.
- Develop evolution as an artist, educator, and researcher through a final evidence-portfolio of growth and research presentation.

Curriculum

The Master of Arts in Art Education program is flexible and highly customizable. Students can complete their 500-level coursework, the first 27 credits, in any order. This includes four core courses and 15 elective credits of the student's choosing. When all 500-level courses are complete, the student must pass the Capstone Readiness Exam. Upon passing, the student is eligible to enroll in the 600-level core courses: Mission of Teaching and Capstone Research. These courses must be taken in order and can not overlap. At the end of Capstone Research, students present their capstone research project and paper and graduate from The Art of Education University.

Proctored Events

Degree-seeking students must successfully complete a minimum of three proctored events: a core course proctored event, the Capstone Readiness Exam, Capstone Research Presentation. Spaced throughout the program, these are designed to:



- Measure the student's knowledge and understanding of core courses.
- Assess the student's ability to apply learning to their teaching in dynamic ways.
- Affirm that the student who takes an assessment is the same person who enrolled in the
 program and that the examination results reflect that same student's own knowledge and
 competence in accordance with the course and program learning outcomes.
- Showcase and celebrate learning from the degree program.

Tuition

All courses use a rolling enrollment model. This allows students to pay for courses individually throughout the degree program.

- The bulk of the core and elective courses (27 credits) are 500-level courses: \$349/credit.
- The final core courses, Mission of Teaching (3 credits) and Capstone Research (6 credits), are 600-level courses: \$399/credit.
- The total tuition for the degree program is \$13,014.

Fees

Fees are in addition to tuition and are non-refundable:

- Transcript processing fee: \$10/paper transcript and \$6/electronic transcript. A courtesy transcript will be sent with the diploma at the successful completion of the degree program.
- Application fee: \$50
- Capstone Readiness Exam fee (proctored exam): \$200

Textbooks and Supplies

The total cost is dependent on the course and electives selected. Click here to see the estimated costs for each course.



- Required texts are estimated at \$15-\$30 each.
- Required materials are estimated at \$50-\$100 per studio course.

Total Degree Cost: \$13,264 + any required books/art materials

Experience

The Master of Arts in Art Education from The Art of Education University is a 36-credit online master's degree program designed for K-12 art teachers. The Student Journey illustrates the degree from application submission to graduation. The master's degree is designed to be flexible, relevant, and affordable.

Flexible: The Art of Education University suggests students complete the degree in two years. Because each student may have unique goals, the timeline is flexible. Students may complete the degree in as little as one year.

Relevant: The master's degree is highly customizable. Students can choose from a variety of elective courses to satisfy their 15 elective credits. Each student works one-on-one with someone who is an art teacher and academic advisor who helps them choose electives and plan coursework. The goal is to create a personalized degree plan aligned with their unique goals.

Affordable: The Art of Education University offers a flexible timeline and students can pay-as-they-go. At about half the cost of comparable online master's degrees in art education, students at AOEU can pay out of pocket or leverage district funding. Students take courses when it makes sense with their funding.

After completing the 36-credit degree program, students graduate with a Master of Arts in Art Education Degree from The Art of Education University.

Application Requirements

The application is designed to showcase students' professional qualifications, passion for art education, and ability to succeed in a master's level program. All components are submitted through the AOEU website. Details and requirements are included in the application.

The application has three main components:

- 1. A 1-3 minute video of intent
- 2. A professionally written explanation of their "why"
- 3. A collection of four images and captions

Application Review

Review begins when the application and official transcripts are on file. Applicants are notified of program acceptance status via email. Denied applicants may reapply to be considered again for acceptance. All fees will apply.


Program Enrollment

Accepted candidates must complete their enrollment agreement. It is signed by the student and the President of the university. Students can access their enrollment agreement in their online account. This document stays on file and serves as the agreement for the duration of the degree program. As indicated on the enrollment agreement, AOEU reserves the right to change tuition, policies, and fees for future terms. The university will provide written notification of changes no later than 90 days prior to the effective change date.



Master of Arts in Art Education

The Master of Arts in Art Education at The Art of Education University is designed specifically for art educators. Students can meet their professional goals while working at a flexible pace that fits their lifestyle.



COURSES

Experience

The Art of Education University offers over 20 practical, relevant, and engaging graduate courses. All courses are accredited and may be used for relicensure, professional development hours, or earning credits toward the master's degree. Students should confirm with their state or district for approval. Students interact with faculty and peers and access their coursework through the LMS. Assignments are scored based on the requirements outlined in the course syllabus.

Coursework at The Art of Education University is designed to be engaging and relevant to art teachers' professional practice. Students submit written and hands-on work and connect with peers and faculty through weekly discussion topics. Faculty provides feedback every week on all assignments.

Intellectual Property

The Art of Education University owns all proprietary rights, including patent, copyright, trade secret, and trademark rights, to all instructional and learning materials provided in conjunction with enrollment. No portion of the materials may be copied or otherwise duplicated nor may the materials be distributed or transferred to any other person or entity. ADMISSIONS

Requirements

All students are required to submit official transcripts documenting a bachelor's degree or higher from an appropriately accredited institution. This requirement is for any student taking individual courses and those enrolling in the master's degree program.

Individual Courses

Students can enroll in courses through the 27th at 11:00 p.m. Central time (UTC-5) each month prior to the course start date. Course participants must complete the following steps at enrollment:

- 1. Have official transcripts sent directly from the issuing institution to The Art of Education University.
- 2. Confirm or demonstrate English language proficiency (see International Students).
- 3. Pay for the course in full (see Tuition Requirements). Payment is acknowledgement that the student will adhere to and is subject to the university policies and procedures in the university catalog.

Tuition Requirements and School Purchase Order Collections

Full payment is required from individual students before they can officially enroll in a course. Prospective students may pay electronically. Other payment options include:

- 1. Pay with a school/organization-issued credit card.
- 2. Pay with a school/organization purchase order (PO)*.
- 3. Pay with a private loan.

REGISTRAR

Credit Hour Policy

The Art of Education University uses the industry-standard Carnegie Unit to define credit hours. All courses are based on semester credit hours. In an 8-week term, courses are measured by the learning outcomes normally achieved through 45 hours of student work for one semester credit where one credit/semester hour is 15 hours of academic engagement and 30 hours of preparation.

For the average student in a three-unit class, a student spends 5-6 hours per week engaging within the course and does 11-12 hours of outside preparation. In certain circumstances, it is possible to have more hours but not less.

Transfer Credits

Master's degree students who have completed coursework outside of AOEU may request an evaluation for transfer credit. Transfer credit requests are accepted until the Capstone Readiness Checkpoint. All transfer credit requests are reviewed by the Registrar. To submit a request, complete the Transfer Credit Request Form.

Note: A minimum of 18 credit hours must be taken through The Art of Education University. Transfer credit is limited. Review the policy in its entirety for details.

AOEU Courses From Morningside College

Students may transfer up to 50% of the total degree program credits (or 18 graduate-credit hours) from AOEU courses taken through Morningside as long as the following conditions are met:

- The courses were taken for graduate credit.
- The final grade earned for each potential transfer course is a B or higher.

Note: Some course topics may not be accepted for transfer due to time limits imposed or credit equivalency. This is to ensure the learning is relevant to achieving the program outcomes.

Note: Retired AOEU courses will be subject to approval and are not guaranteed to transfer.

Other Colleges and Universities

External coursework may be considered for elective transfer credit if all of the following conditions are met. Consideration does not guarantee transfer credit acceptance.

 No more than nine (9) graduate-credit hours for work completed outside of AOEU may be counted toward an AOEU Master of Arts in Art Education degree.



- The coursework must be graduate level (500-level or above).
- The coursework is completed at an appropriately accredited institution.
- The course syllabus and objectives demonstrate learning in the field of art education or another graduate-level topic in the field of education.
- The final grade earned for each potential transfer course is a B or higher.
- The coursework does not duplicate, overlap, or regress previous work.
- The coursework did not count towards undergraduate graduation requirements.

Note: Some course topics may not be accepted for transfer due to time limits imposed or credit equivalency. This is to ensure the learning is relevant to achieving the program outcomes

Requesting Transfer Credit

Requests for transfer credits may be submitted until the Capstone Readiness Checkpoint. The Transfer Credit Request Form is required to begin this process. Students are strongly encouraged to complete the form prior to enrolling in additional coursework to ensure transfer. Course details, including the course title, description, official transcript, and a course syllabus, are required for the transfer credit approval process.

The Art of Education University does not guarantee transfer credit acceptance. Accepted coursework will display on the student's course records page on the AOEU website once processed. Grading Requirements

- Master's degree students must earn a B (80%) or higher, or a minimum of a 3.0 GPA, at the completion of each course to earn graduate credit towards program completion.
- Graduate students must earn a B (80%) or higher at the completion of each course to earn graduate credit for an individual course offering.



Course Repeat Policy

All students may repeat a course to earn a better grade. If choosing to repeat a course, all applicable fees and tuition must be paid. All course attempts will be included in the official transcript. Only the most recent grade will factor into the student's GPA. Students who earn a C (79%) or less in a given course or who receive a final grade of W (withdrawal) two times in the same course must retake the course to proceed in the degree program in accordance with the Academic Probation Policy.

Change of Grade and Grade Appeal Procedure

A student may appeal the grade for an individual assignment grade and/or final course grade.

If a student feels a grade is an unfair representation of their achievement, the student should first contact the instructor. If the outcome of this correspondence is unsatisfactory, the student should contact the Dean of Instruction (deanofinstruction@theartofeducation.edu) who will discuss the issue with the instructor. The student will receive a response within three business days of filing the complaint.

Program Withdrawals

Students who are accepted into the degree program, and no longer intend to continue with the completion of the degree program, can officially withdraw from the program. The student will be refunded, according to the Tuition Reimbursement Policy, for any courses they are currently enrolled in or have prepaid for at the time of withdrawal from the program.

Payment Options

Pay-As-You-Go

Most students at AOEU pay for courses as they progress through the degree program. This allows students to pay for one course at a time throughout the duration of the degree. Paired with flexible timelines, students may be able to graduate without additional student loan debt.

Academic Integrity Policy

The Art of Education University believes academic integrity is essential in order to maintain the validity of all grades earned and to protect the integrity of the university, students, and graduates. Therefore, AOEU adheres to the highest standards when it comes to student scholarly work.

All work submitted and/or presented by students must be original and must properly cite all outside inspiration. Original cited work includes, but is not limited to, individual and group assignments in written, oral, and electronic forms, as well as any artistic creations.

Plagiarism

Plagiarism is a major form of dishonesty. Examples of plagiarism include, but are not limited to:

- Purchasing and/or deliberately taking someone else's work (written, artistic, or otherwise) and submitting it as their own.
- Incorrectly citing resources or creating fictitious resources.
- Using a direct quote without including quotation marks and/or appropriate citation.
- Submitting direct quotes as paraphrased text.
- Paraphrasing text without using the appropriate citation.
- Taking an assignment (or substantially similar assignment) completed for one course/program and submitting it to another AOEU course/program.

Violations, Academic Probation, and Dismissal

AOEU follows the Academic Integrity Policy to determine probation and dismissal of students in courses.

Any work in violation of the Academic Integrity Policy will result in grade deductions and/or dismissal. Violations are cumulative for the duration of the student's tenure at the university.

- On the student's first offense, the instructor will have the option to allow resubmission of the assignment for half credit.
- The second violation will result in zero credit (grade entered as zero) for the assignment without the option of resubmission.
- Any additional violations will lead to a failing grade, dismissal from the course(s) enrolled, and a refund according to the Transfer, Withdrawal, and Tuition Reimbursement Policy.
- Students who already have an academic integrity violation on record from a previous course and who incur additional course infraction(s) are subject to penalties, including failure of assignment,



failure of course, and/or university dismissal. The Chief Academic Officer will review all such cases and make a final decision within 10 calendar days. Students in this situation will have the right to submit further documentation or explanation on their behalf.

Students should consult their instructor with questions regarding the policy.



Academic Probation and Dismissal Policy

The Art of Education University is committed to the academic success and positive experience of all students and reserves the right to dismiss students for specific infractions detailed below.

Academic Probation

Master's degree students must earn a B (80%) or higher, or a minimum of a 3.0 GPA, upon completion of each course to earn graduate credit toward program completion. Master's degree students earning 79% or less on required core courses will be placed on academic probation until the course is retaken with an earned grade of 80% or higher. In order to repeat a course, all applicable fees and tuition must be paid.

Violations and Dismissal

AOEU follows the Academic Integrity Policy and the Student Code of Conduct Policy to determine the dismissal of students. Students who are dismissed will be removed from the course and program. All current and prepaid future courses will be issued a refund according to the Transfer, Withdrawal, and Tuition Reimbursement Policy. Students dismissed from AOEU are ineligible for future enrollment.

It is the student's responsibility to understand and uphold AOEU policies. Students should consult their instructor with questions.



Admissions Policy

Requirements

All students are required to submit official transcripts documenting a conferred bachelor's degree or higher from an appropriately accredited institution. This requirement is for any student taking individual courses and those enrolling in the master's degree.



Individual Courses

Courses are available to enroll until the 27th at 11:00 p.m. Central time (UTC-5) each month prior to the course start date. Course participants must complete the following steps at enrollment:

- 1. Have official transcripts sent directly from the issuing institution to The Art of Education University.
- 2. Confirm or demonstrate English language proficiency (see International Students).
- 3. Review and sign enrollment agreement to confirm receipt of AOEU's course expectations and policies.
- 4. Pay for the course in full (see Tuition Requirements).

Master's Degree

The application is designed to showcase students' professional qualifications, their passion for art education, and to demonstrate their ability to succeed in a master's level program. All components are submitted through the AOEU website. Details and requirements are included in the application.

- 2. A professionally written explanation of their "why"
- 3. A collection of four images and captions

Student Rights

Cancellation Policy

Course Cancellation Policy

All AOEU courses require a minimum enrollment of three students by 11:00 p.m. Central time (UTC-5) on the 27th of the month prior to the course start date. Should a course fail to meet the minimum enrollment requirement, the class will be canceled. Registered students will be notified and will have the option to transfer to a concurrent or future course offering without penalty or receive a 100% tuition reimbursement.



Confidentiality and Privacy Policies

Student Confidentiality

The Art of Education University complies with The Family Educational Rights and Privacy Act (FERPA) of 1974. FERPA was designed to protect the privacy of educational records, to establish the rights of students to inspect and review their educational records, and to provide guidelines for the correction of inaccurate or misleading information through informal and formal hearings.

FERPA Notification

AOEU maintains various records concerning students to document their academic progress and interactions with other university staff.

The Family Education Rights and Privacy Act (FERPA) affords eligible students certain rights concerning their education records. These rights include:

1. The right to inspect and review the student's education records within 45 days after the day AOEU receives a request for access. Due to the online and remote nature of the institution, the vast majority of a student's records can be located within the student's AOEU account on The Art of Education University website. Those participating in a course will also have full access to all instructor comments and notes through the progression of their course through AOEU's learning management platform. Students seeking additional information, outside of the scope listed



- above, should submit a written request to the Office of the Registrar at registrar@theartofeducation.edu identifying the specific record(s) the student wishes to inspect.
- 2. The right to request the amendment of the student's education records the student believes to be inaccurate, misleading, or otherwise a violation of the student's privacy rights under FERPA. Students requesting an educational record amendment need to contact the Office of the Registrar, clearly identifying the part of the record the student wants to be changed and specify why it should be changed. If The Art of Education University decides not to amend the record as requested, AOEU will notify the student in writing of the decision and the student's right to a hearing regarding the request for amendment. Additional information regarding the hearing procedures will be provided to the student when notified of the right to a hearing.
- 3. The right to provide written consent before AOEU discloses personally identifiable information (PII) from the student's education records, except to the extent FERPA authorizes disclosures without consent. The Art of Education University discloses education records without a student's prior written consent under the FERPA exception for disclosure to school officials with legitimate educational interests. A university official is typically a person employed by AOEU in an administrative, supervisory, academic, research, or support position (including law enforcement personnel); a person serving on the board of trustees; or a student serving as an official volunteer or contractor outside of AOEU who performs an institutional service of function for which the school would otherwise use its own employees and who is under the direct control of the institution with respect to the use and maintenance of PII from education records, such as an attorney, auditor, collection agent, or a student volunteering to assist another university official in performing their tasks. A university official typically has a legitimate educational interest if the official needs to review an education record in order to fulfill their professional responsibilities for AOEU.

Course Progress Policy

Attendance

Most courses are asynchronous with no required weekly login times. Students may work at their own pace, and even work ahead, as long as they meet the required weekly due dates. Capstone Research requirements include several synchronous activities to plan and present the final capstone project. All other courses are asynchronous.

Course: Satisfactory Academic Standing

To maintain satisfactory academic standing (SAP), students must submit assignments and participate in course discussions each week. To earn graduate credit, students must earn a minimum GPA of 3.0 or a grade at or above a B (80%). Students who do not earn a B or above and who withdraw from an individual course two times are subject to the Academic Probation Policy. Credit hour completion is the quantitative measure of SAP whereby a student must complete their program within 150% of the published credits of the program. For example, the master's degree program is 36 credits which requires students to satisfy all requirements of the program without having to attempt more than 54 credits.



Capstone Readiness Exam Policy

Students enrolled in AOEU's Master of Arts in Art Education degree program must pass the Capstone Readiness Exam. Students can begin the exam after the Capstone Readiness Checkpoint is successfully completed. Once started, the exam must be completed within seven days.

Only students who have passed this assessment will be allowed to continue on in the master's degree program and enroll in their final two courses: Mission of Teaching and Capstone Research. Students who do not pass the exam will need to meet with their academic advisor to complete another Capstone Readiness Checkpoint and remit an additional exam fee.

Late Work

All assignment deadlines are determined by the instructor and posted online. Late work will be noted by the instructor and result in a point deduction in accordance with the grading rubric. It is the student's responsibility to check the grade book frequently. Any questions or concerns should be brought to the attention of the course instructor. Students should contact their AOEU instructor immediately should an unforeseeable circumstance prevent them from completing an assignment by the assigned date to discuss extension options.

Assignment Extensions

AOEU instructors will work with students to set reasonable extensions (an agreed upon time frame to both the instructor and student) for assignments when unforeseen situations arise. To qualify for an extension, students must reach out to their instructor at least 24 hours before a due date to communicate their inability to complete the assignment on time. Point deductions will not occur for prearranged extensions. Point deductions will occur if the instructor is notified within 24 hours or after the assignment due date.

Course Incompletes

All work must be completed by the course end date, regardless of extensions given within the course for individual assignments. If special circumstances arise regarding the end date of a course, students should reach out to their instructor. In extenuating circumstances, an extension of no more than seven days may be granted beyond the end date of a course.





Grading Policy

Grade Point Average (GPA)

The Art of Education University uses the following grading scale to compute grade point averages and assign grades. Transfer credits are not included in the GPA. Master's degree students can view their GPA in their AOEU account on the Manage My Degree page.

Grading Requirements

- Master's degree students must earn a B (80%) or higher, or a minimum of a 3.0 GPA, upon completion of each course to earn graduate credit toward program completion.
- Graduate students must earn a B (80%) or higher at the completion of each course to earn graduate credit.

Course Repeat Policy

All students may repeat a course to earn a better grade. In order to repeat a course, all applicable fees and tuition must be paid. All course attempts will be included in the official transcript. Only the most recent grade will factor into the student's GPA. Students who earn a C (79%) or less in a given course or who receive a final grade of W (withdrawal) two times in a course must retake the course to proceed in the degree program in accordance with the Academic Probation Policy.



Academic Probation

Master's degree students must earn a B (80%) or higher, or a minimum of a 3.0 GPA, upon completion of each course to earn graduate credit toward program completion. Master's degree students earning a C (79%) or less on program courses or who withdraw from a specific course two times will be placed on academic probation until the course is retaken with an earned grade of 80% or higher. In order to repeat a course, all applicable fees and tuition must be paid. The Course Repeat Policy applies.

Evaluation Method

Students are expected to submit assignments by the due date and participate in all discussions. Posts and peer responses will be evaluated by the instructor using the course rubric and assignment quidelines. Students are encouraged to work on assignments in their numerical order.

Grade Book

Ongoing course grades are posted in the LMS grade book and can be accessed by students at any time. It is the student's responsibility to check the online grade book frequently. Students are encouraged to contact the course instructor with questions or concerns about assignments.

Note: The LMS online grade book does not serve as an official transcript.

Certificate of Course Completion

Official certificates of completion are available to students who have submitted an official transcript confirming an earned bachelor's degree or higher from an accredited institution and completed their course. Once a student's file is complete, a certificate of completion can be downloaded from the student's course records page. Certificates of completion are available 10 days after the course end date. Students will receive an email notification when their certificate of completion becomes available for download.

Submission of Transcripts

There are two options for sending official transcripts:

Once official documentation of an earned bachelor's degree or higher has been received and reviewed, AOEU course records will be available.

Transcript Request

Students may request an official paper or electronic transcript when the certificate of completion is available. Students can request official transcripts in their AOEU account by selecting "Request Official Transcripts" on the Records page.

The Art of Education University

Individual Courses: There is a \$10 charge for each requested paper transcript and a \$6 charge for each requested electronic transcript.

Master's Degree Program: Graduates receive a complimentary official transcript with their diploma. Additional transcripts are \$10 and can be requested at any time after program completion. Additional processing fees apply for overnight transcript delivery.

Morningside College

There is a \$7.50 charge for each requested transcript. Expedited transcripts are available through Morningside College for an additional fee.

Change of Grade and Grade Appeal Procedure

A student may appeal the grade for an individual assignment and/or final course.

If a student feels a grade is an unfair representation of their achievement, the student should first contact the instructor. If the outcome of this correspondence is unsatisfactory, the student should contact the Dean of Instruction at deanofinstruction@theartofeducation.edu, who will discuss the issue with the instructor. The student will receive a response within five business days of filing the complaint.



Graduate-Credit Information

Acceptance of Transfer Credit Disclosure

The Art of Education University cannot guarantee credits will be accepted as transfer credit at another institution. Students are advised to check with the degree-granting school, state, or district to verify the credits will be accepted for license renewal, salary advancement, or use in another degree program.



Acceptance of Program Disclosure

It is the responsibility of the student to check with their state's Department of Education to verify this program leads to the desired pay raise or change in certification status. No internship is included in this program. The degree is not designed to lead to licensure or teaching credential.

The Art of Education University cannot guarantee employment or promotion as a result of participating in this master's degree program.

Course Grading

All students earn a letter grade, which is scored based on the rubrics and requirements outlined in the course syllabus. The Art of Education University follows a rigorous academic model of the highest standard for curriculum development and student assessment. Students are encouraged to check the online grade book within the learning management system to access grades at any time. Any questions or concerns should be directed to the course instructor.

Grading Timelines

A certificate of course completion will be available through AOEU's student records page 10 days after the course end date. Students will receive an email notification when grades are ready to view. They can log into AOEU's website to download and print out a copy of their certificate of completion as long as their transcript documenting a bachelor's degree or higher has been received and processed.

Official Transcripts

The Art of Education University

Students may request an official paper or electronic transcript once a notification of a certificate of completion is received. To request an official transcript:

- 1. Log into the AOEU account.
- 2. Select "Records."
- 3. Select "Request Official Transcript" (bottom of the page).

Individual Courses: The final grade and number of credits earned will be indicated on the certificate of completion, which is available 10 days after the course end date. The certificate of completion can be downloaded from the student records page on the AOEU website. Once official certificates of completion have been received, students may request an official paper or electronic transcript by selecting the "Request Official Transcript" button on the bottom of the records page. There is a \$10 charge for each requested paper transcript and a \$6 charge for each requested electronic transcript.

Master's Degree Program: Upon successful completion of the master's degree program, all graduates receive a complimentary official transcript with their diploma. Additional transcripts can be requested at any time after program completion. There is a \$10 charge for each requested paper transcript and a \$6 charge for each electronic transcript.



Morningside College

The final grade and number of credits earned will be indicated on the certificate of completion, which is available 10 days after the course end date.

The certificate of completion can be downloaded from the student records page on the AOEU website. Once official grade reports have been received, students may request an official paper or electronic transcript by selecting the "Request Official Transcript" button on the bottom of the records page. There is a \$7.50 charge for each requested transcript.

Morningside College

Expedited transcripts are available through Morningside College for an additional fee. Visit https://www.morningside.edu/alumni/professional-development/transcripts/ for more details.

Transfer Credit Acceptance

Students seeking to transfer graduate credits to a graduate program at another institution are advised to obtain prior approval from said institution, documenting that AOEU courses will be accepted and count toward the desired degree. Up to nine AOEU credits will transfer as an elective to any program inside Morningside College. Morningside College credits carry Higher Learning Commission accreditation.



Student Complaints and Grievance Policy

The Art of Education University is committed to hearing the concerns of its students. Degree-seeking students who have three course climate offenses will be removed from the program entirely and issued a refund according to the Transfer, Withdrawal, and Tuition Reimbursement Policy.

Payment Options

Pay-As-You-Go

Most students at AOEU pay for courses as they progress through the degree program. This allows students to pay for one course at a time throughout the duration of the degree. Paired with flexible timelines, students may be able to graduate without additional student loan debt.

Responsible Borrowing

Many students need to borrow money to finance their college degree. Taking out a student loan may be the key to investing in the future, and it is important to borrow responsibly. This means only borrowing for what is needed. Track the loans every year and only borrow for school-related expenses to minimize the debt burden upon graduation.

Private Student Loans

Private student loans are education loans funded by a third party lender. Private student loans require a separate application, credit review, and cosigner. Private student loans cannot be consolidated with federal student loans. We encourage students to limit their borrowing of private loans because the repayment terms are not as flexible, and the interest rates are much higher than the federal loan rate.

The Art of Education University does not have a preferred lender list or recommend any lenders. Some degree-seeking students have found success working with Climb Credit.

Transfer Credit Policy

Overview

Master's degree students who have completed coursework outside of AOEU may request an evaluation for transfer credit. Transfer credit requests are accepted until the Capstone Readiness Checkpoint. All transfer credit requests are reviewed by the Office of the Registrar.

Note: A minimum of 18 credit hours must be taken through The Art of Education University. Transfer credit is limited. Review the policy in its entirety for details.

Requesting Transfer Credit

Requests for transfer credits may be submitted until the Capstone Readiness Checkpoint. The Transfer Credit Request Form is required to begin this process. This form is linked below and available on the AOEU website under Registrar. Students must be logged into the AOEU website to access the form. Students are strongly encouraged to complete the form prior to enrolling in additional coursework to ensure transfer. Course details including the course title, description, official transcript, and a course syllabus are required for the transfer credit approval process. Transfer Credit Request Form

The Art of Education University does not guarantee transfer credit acceptance without prior approval. An official transcript documenting the culminating coursework and grade is required for final processing. Accepted coursework will display on the student's course records page on the AOEU website once processed. Questions concerning transfer credits should be directed to AOEU's Registrar at registrar@theartofeducation.edu or **515.236.5094**.

AOEU Courses From Morningside College

Students may transfer up to 50% of the total degree program credits (or 18 graduate-credit hours) from AOEU courses taken through Morningside as long as the following conditions are met:

- The courses have been completed within five years of the program acceptance date.
- The courses were taken for graduate credit.
- The final grade earned for each potential transfer course is a B or higher.



Coursework that aligns with and meets the criteria of AOEU programs will be automatically transferred and accepted at program acceptance. Accepted coursework will display on the student's course records page on the AOEU website once processed. A minimum of 18 credit hours must be taken through The Art of Education University.

Note: Retired AOEU courses will be subject to approval and are not guaranteed to transfer.

Other Colleges and Universities

External coursework may be considered for elective transfer credit if all of the following conditions are met:

- No more than nine graduate-credit hours for work completed outside of AOEU may be counted toward an AOEU Master of Arts in Art Education degree.
- The coursework must be graduate level (500-level or above).
- The coursework is completed at a regionally or nationally accredited institution.
- The courses are completed within five years of the program acceptance date.
- The course syllabus and objectives demonstrate learning in the field of art education or another graduate-level topic in the field of education.
- The final grade earned for each potential transfer course is a B or higher.
- The coursework does not duplicate, overlap, or regress previous work.
- The coursework did not count towards undergraduate graduation requirements.

Complete the Transfer Credit Request Form to request an evaluation of courses from outside institutions. A minimum of 18 credit hours must be taken through The Art of Education University.

Deadline

All requests for transfer credit and official transcripts documenting credits earned are required to be submitted at least one week prior to the Capstone Readiness Checkpoint.

Criteria for Assessment

All transfer credits must first be officially accepted into the university through the Office of the Registrar. Students should contact The Art of Education University directly for additional details regarding transfer credit policies at registrar@theartofeducation.edu. In order for approved transfer credit to be awarded, students must submit a Transfer Credit Request Form that includes a course syllabus that aligns to the date the course was taken and official transcripts that clearly indicate all of the following information for each course:

- Course codes or numbers
- Course titles or descriptions



- · Final grades earned
- Course credits earned




Transfer, Withdrawal, and Tuition Reimbursement

Internal Transfer Policy

Students may transfer to a future AOEU course at any time before midnight Central time (UTC-5) on the course end date. Transfer requests made after midnight Central time (UTC-5) on the seventh day of the course will be documented as a formal withdrawal (W) on the student record. Transfer requests after the course end date will not be accepted. The course end date is detailed on each course landing page and the course enrollment form. Transfers to any course currently available for purchase on the AOEU website will be approved. Students can transfer to a future course by following the official transfer process detailed below. A maximum of two transfers is allowed for each individual course. Any requests beyond two transfers will result in tuition reimbursement per the Tuition Reimbursement Policy, the Course Repeat Policy, and the Academic Probation Policy.

Transfer Process

To submit an official transfer request, click on the word "Transfer" (blue text directly above the course price) on the course records page on The Art of Education University website. Students need to be logged into their student account to process all requests.



Withdrawal Policy: Individual Course


Students are eligible for 100% tuition reimbursement at any time before midnight Central time (UTC-5) on the last day of the course. Withdrawal requests made after midnight Central time (UTC-5) on the seventh



day of the course will be documented as a formal withdrawal (W) on the student record. Students can receive reimbursement by following the official withdrawal process outlined below.

Official Withdrawal Process

To submit an official withdrawal request, click on "Withdrawal" (blue text directly above the course price) on the course records page on The Art of Education University website. Students need to be logged into their student account to process all requests.



Course withdrawals are available until midnight Central time (UTC-5) on the last day of the course. Withdrawal requests after the course end date will not be accepted. The course end date is detailed on each course landing page and the course enrollment form.

Unofficial Withdrawal Process

Graduate-credit students who are inactive for 50% or more of the course consecutively are considered an unofficial withdrawal (UW) and issued a refund according to the Tuition Reimbursement Policy. Unless prior approval to not participate was granted by the instructor, evidence of academic attendance includes assignment submissions, quiz or exam submissions, discussion board posts, and/or academic inquiries to the instructor.

Degree Program: Satisfactory Academic Progress

If a student fails to enroll in a course for one year's time, they will be sent a letter requesting communication regarding their intentions of completing the degree. The student will have the option to continue with the program by enrolling in a course or officially withdrawing from the program. If the student fails to respond to the written correspondence, the student will be unofficially withdrawn from the degree program at their five-year degree program expiration and will need to reapply to continue with a degree-seeking candidacy. All fees, rules, and regulations will apply.

Withdrawal Policy: Degree Program

Students who are accepted into the degree program, and no longer intend to continue with the completion of the degree program, can officially withdraw from the program. The student will be refunded, according to the Tuition Reimbursement Policy below, for any courses they are currently enrolled in or have prepaid for at the time of withdrawal from the program.



Official Withdrawal Process

To submit an official program withdrawal request, please contact an academic advisor directly.

Course withdrawals are available until midnight Central time (UTC-5) on the last day of the course. Withdrawal requests made after midnight Central time (UTC-5) on the seventh day of the course will be documented as a formal withdrawal (W) on the student record. Withdrawal requests after the course end date will not be accepted. The course end date is detailed on each course landing page and the course enrollment form. Additional program fees will not be refunded.

Degree Program Duration

Students who have not successfully completed the degree program at the conclusion of five years will automatically be withdrawn (UW) from the program. Students will need to reapply for the program. All fees, rules, and regulations will apply. Additional program fees will not be refunded.

Tuition Reimbursement Policy: Individual Course

Students who submit an official withdrawal request, and those who are unofficially withdrawn from a course, are eligible for a refund according to the following schedule below. Refunds will be processed for the original transaction amount. Discount codes cannot be reused. Additional program fees will not be refunded.

Tuition Reimbursement Policy: Degree Program

Students who submit an official program withdrawal request are eligible for a refund for any courses they are currently enrolled in or have prepaid for at the time of withdrawal from the program, according to the schedule below. Refunds will be processed for the original transaction amount. Discount codes cannot be reused. Additional program fees will not be refunded.

Discounts

AOEU occasionally offers discount codes to defined groups or during special promotions. The discounted amount will not be refunded as part of AOEU's Tuition Reimbursement Policy.

Course Objectives

- ✓ Learn about the field of art therapy and identify the underlying differences between art therapy and art education.
- Explore the functions of behavior and how personal observations can inform responses in the art classroom.
- ✓ Identify professionals in and around the building and engage in proactive and positive conversations to support students.
- ✓ Participate in art therapy-inspired activities and consider meaningful and ethical incorporation into the classroom.
- ✓ Create resources and instructional materials that can be used in the art room.

Course Description

Art is a powerful tool for communication, motivation, and healing. In this course, participants will gain an understanding of the field of art therapy and the role of the art therapist as compared to the role of the art educator. Participants will learn how to harness the power art yields with creative strategies designed for the art classroom. Such strategies will help the art educator foster self-esteem and self-awareness, cultivate emotional resilience, and promote creative insight in themselves and students.

The art therapy field is led by professional art therapists dedicated to and trained in mental health and human services. This course will not lead to certification or licensure in art therapy.

- ✓ Prepare authentic assessment tools that encourage meaningful student growth.
- ✓ Plan methods for collecting and organizing student and instructor data.
- ✓ Apply data collection measures as a means for reflection and advocacy.
- ✓ Establish and present a professional stance concerning the role of assessment in the art classroom.

Course Description

Diagnostic, formative, and summative assessments are critical tools within the art educator's classroom. When teacher-led assessment is used alongside student learning tools such as self-assessment and peer-assessment techniques, a comprehensive picture of student growth and evaluation can be formed.

In this course, participants will learn the distinction between assessment for learning and assessment of learning in the unique art classroom. The course will empower art educators to collect, analyze, and speak to the data collected for both student growth and to advocate for the needs within the art classroom for achievable learning outcomes. Participants will use their current lesson plans to create new and effective assessment strategies for immediate application in their classrooms.

During this course, participants will gain a foundational understanding of students on the autism spectrum and special education law. This course provides opportunities to create instructional tools to support routines and transitions and facilitate valuable practice when it comes to decoding student behavior. As a result of this course, participants will be exposed to a variety of strategies and ideas to improve their teaching practice to ensure art instruction is differentiated for students on the spectrum.

Throughout this course, participants will apply the strategies learned to create and implement real classroom activities that model the flipped classroom approach.

- Explore and review the digital resources from a variety of art museums, both in the United States and around the world, and envision the utilization of such tools among students.
- ✓ Research and present a local art museum visit, which can supplement evolving lessons.
- ✓ Develop art history resources to help facilitate studio explorations, discussions, and critiques.
- ✓ Compose an action plan that outlines goals for the implementation of art history concepts.

Course Description

Making art history relevant is a common struggle in K-12 art classrooms. Trying to appeal to student interests while maintaining the integrity and richness of art history can be accomplished through personalized and dynamic strategies for art appreciation that will appeal to today's students. This has profound implications when it comes to fostering art appreciation among students of all ages. In this course, participants will survey hundreds of years of art as they simultaneously plan rich learning opportunities for their students in diverse and dynamic settings.

Course Description

Today's technologies have transformed many elements of the human experience, including how people connect, communicate, and gather information. As a result, tools like the iPad are increasingly entering the classroom with significant implications for student learning as well as instructor engagement.

Participants in this course will examine and debate contemporary resources concerning tablet usage in the K-12 classroom. Course Objectives

- √ Assess and reflect upon professional practices to extend knowledge, improve instruction, and refine a personal management philosophy.
- ✓ Investigate current research in the field and discuss a variety of effective instructional and management strategies to establish routines and procedures, create a calm, productive, respectful classroom environment, and leverage individual personality and teaching style to reach students.
- ✓ Understand that individual identities can be shaped by the social and cultural groups to which they belong.
- ✓ Evaluate and apply current research in the field to identify and present successful management strategies for working with targeted populations.
- ✓ Develop a comprehensive classroom management action plan that includes time management (instructional, planning, etc.), space and material management, and strategies for collaborating with students, colleagues, and the community.

Course Description

Management of the art room involves a unique blend of strategies and techniques to hold students accountable, manage materials and resources, design procedures to keep the art room running efficiently, and establish an enjoyable, creative learning environment.

Participants will examine and apply current research in classroom management strategies to their art teaching practice. Reflecting on their current practice, they will expand their own learning and embark on new methods to promote learning in the classroom. Attention will be given to how social identities are formed and how they influence students' interaction with content and others. The final product in the course is a full classroom management action plan.

Course Description

Project-based learning is known to increase students' ability for heightened critical thinking, productive collaboration, and effective problem-solving. It also aids in building stronger communication and enhanced creativity. Through this class, participants will research the most popular collaborative education models today, encompassing both school-wide initiatives and project work exclusive to the art room. Topics will include design thinking, makerspaces, STEAM/STEM, PBL (project-based learning), school-wide collaborative projects, and arts integration.

Participants will leave the class with a clear understanding of the type of project-based work that will benefit an individual program as well as a plan to actively redesign and customize collaborative curriculum.





Reaching All Artists Through Differentiation

- ✓ Motivate even the most reluctant students and get them excited about art.
- √ Revamp lessons and optimize them for all learners.
- ✓ Conduct interest and strength inventories to use in the art room.
- ✓ Draw from best practices in differentiation strategies.

Course Description

Differentiation is no longer a teaching strategy for the ambitious in education. Rather, it's an expectation for everyone, including the art educator. There are many ways to meet student needs through a variety of types of differentiation. By learning how to help students to experience success in developmentally appropriate activities, that will, in turn, help to increase their engagement in art.

During this course, participants will use the appropriate tools to maximize learning for all students: gifted learners, English language learners (ELL), special education students, and struggling students while acknowledging their unique interests. An important component of this approach is for participants to modify their lessons and assessments. At the completion of this course, participants will have a toolkit of applicable strategies for the classroom.

Course participants will investigate a variety of progressive philosophies, including Reggio Emilia, Montessori, and Waldorf as well as techniques for integrating play-based learning and teaching foundational skills. This eight-week intensive course will provide participants with innovative opportunities to explore childhood development, create classroom resources, and revamp their philosophy of teaching younger learners.

Course Description

This studio course requires both hands-on artmaking and learning new teaching methodologies. Participants must demonstrate artistic proficiency in various ceramic techniques and translate the medium for classroom use. Participants will examine the history of ceramics and use that knowledge to practice various handbuilding and surface treatment techniques to develop a body of work. In addition to studio practice, course participants are required to engage with real-world classroom scenarios and troubleshoot supply management and art room organization to facilitate the effective implementation of a ceramics curriculum.





Studio: Drawing

Course Code: AOEU ART526 / Morningside EDUC500 AOE026


Course Objectives

- ✓ Research best practices and explore basic and advanced techniques and media for drawing instruction in the classroom setting.
- ✓ Practice observational drawing skills through a variety of interactive and choice-based exercises.
- ✓ Develop, enhance, or extend the drawing curriculum.
- ✓ Engage in purposeful critique with peers and learn strategies and approaches for the classroom from one another.
- ✓ Push personal drawing practice to the next level by working in a visual journal.
- Create original artwork using a variety of drawing media while reflecting upon personal technical evolution.

Course Description

This course will dive into focusing on the art teacher's growth in their personal practice of drawing as it integrates cross-disciplinary dialogue and offers new strategies for teaching drawing in the classroom. Additionally, it will address and offer solutions for the struggles and challenges students face in the art room as they explore drawing as a skill. During this course, participants will revisit their roles as artists and share their drawing evolution with the instructor and peers as they simultaneously think through best practices for drawing instruction. The journey will include visual journaling using a variety of media and skill development as participants work toward creating a drawing portfolio.

Course Objectives

- ✓ Experiment with a wide variety of 2D and 3D weaving, felting, and embroidery techniques.
- ✓ Learn from art educators and fiber arts experts from around the country who understand the challenges of teaching fiber-infused lessons.
- ✓ Create resources, tools, and hands-on fiber art examples to use directly in the classroom.
- √ Research best practices in the management and organization of fiber arts.
- ✓ Push personal practice to the next level while revamping the fiber art curriculum.

Course Description

This studio course requires both hands-on artmaking and learning new teaching methodologies. Participants must demonstrate artistic proficiency in various fiber art techniques and translate the medium for classroom implementation. Participants will explore 2D and 3D weaving techniques and various other non-woven fiber techniques. Participants will use traditional and innovative fiber arts approaches to develop a body of work. In addition to studio practice, students are required to demonstrate proficiency in curricular development, management, and organization of fiber arts. Teaching methodologies included are applicable to all levels, K-12, and are designed to inspire creative development in all students.





Studio: Painting—Tempera & Acrylic

Timeline 8 weeks

Course Code: AOEUART528 / Morningside EDUC500 AOE028

Course Objectives

- √ Research best practices for tempera and acrylic painting in the classroom setting.
- ✓ Learn from art educators who are successfully taking risks with each media.
- ✓ Create various pieces of artwork while experimenting with new techniques.
- ✓ Create resources and hands-on examples to use directly in the classroom.
- ✓ Push personal practice to the next level while revamping the painting curriculum.

Course Description

Tempera and acrylic are the focus of this studio art course, addressing best practices for use in the K-12 art classroom. Topics will include brush selection, storage, and organization as well as color theory, mixing mediums, and advanced techniques. This is a painting class designed just for art teachers. Participants will have the time and the opportunity to try new techniques firsthand as they create a teacher showcase series and final portfolio.





Studio: Painting-Watercolor

Course Objectives

- Research best practices, including basic, advanced, and color theory techniques for watercolor painting in the classroom setting.
- ✓ Learn from art educators who are successfully taking risks with watercolor.
- ✓ Explore ideation strategies for developing concept-based lessons and artwork.
- ✓ Create resources and hands-on examples to use directly in the classroom.
- √ Develop or extend the watercolor curriculum.
- ✓ Push personal practice to the next level by working in a visual journal with watercolor.
- √ Create original watercolor artwork while experimenting with new techniques.

Course Description

Watercolor is unique because it has transparent qualities unlike any other painting medium. Whether participants are teaching advanced painting at the high school level or are looking for a more successful approach to watercolor at the elementary level, there will be something new to learn in this class. Topics will include brush selection, material management, color theory, visual journaling with watercolor, and basic and advanced techniques for the art room. This course is designed specifically for art teachers which means participants will leave this class full of inspiration for direct application into their art classrooms. Participants will also have time to advance their own practice in watercolor.





Studio: Photography

Course Objectives


- √ Identify and utilize the various features of the camera to creatively control imagery.
- √ Explore the basic qualities of light while embarking upon a series of photographic challenges.
- Engage with timely tools for editing images post-shoot while considering ways to showcase and celebrate artistic endeavors.
- √ Research best practices, including basic and advanced processes, for incorporating photography in the classroom setting.
- ✓ Demonstrate conceptual planning by developing or extending the photography curriculum.
- ✓ Take part in collaborative conversations and critique the work of one another as well as exemplars from the field.
- ✓ Create original photographic work while experimenting with concept, media, and composition.

Course Description

Ansel Adams once said, "There are always two people in every picture: the photographer and the viewer." In this class, participants will take on both of these roles. As the photographer, participants will plan and execute imagery of their own. As the viewer, participants will reflect upon the work of peers as well as other artists. Together, course members will embark upon a mutually powerful learning experience that can influence not only their own personal studio practice but instructional decisions in the art classroom as well.

Participants will learn the basics of photography through the creation of visual stories and explore best practices and meaningful strategies for approaching photography with students. The culmination of the course will include a comprehensive portfolio of studio work alongside practical tools for the classroom.





Studio: Printmaking

Course Objectives

- ✓ Create a wide variety of prints while experimenting with new techniques.
- Learn from art educators and printmaking experts from around the country who understand the challenges of teaching printmaking to students.
- ✓ Create resources, tools, and hands-on printmaking examples to use directly in the classroom.
- Research best practices in the management and organization of printmaking.
- √ Push personal practice to the next level while revamping the printmaking curriculum.

Course Description

This course breaks down various printmaking processes that participants can use with their students at any age level, without advanced equipment, and with all of the safety and developmentally appropriate information they need. Participants will try out various monoprint techniques, image transfers, traditional and nontraditional linoleum prints, collagraphs, and many other unique and alternative processes — no press or chemicals necessary.

As participants create useful tools and finished pieces for the classroom, they will also learn how to break printmaking skills down for their students in a developmentally appropriate way while revamping their printmaking curriculum from the inside out.





Studio: Sculpture

Course Objectives

- ✓ Create resources, tools, and hands-on sculpture examples to use directly in the classroom.
- √ Research best practices in the management and organization of sculpture media.
- ✓ Demonstrate conceptual planning and installation of three-dimensional artworks.
- ✓ Push personal practice to the next level while revamping the sculpture art curriculum.

Course Description

The vast potential for three-dimensional artworks can make teaching sculpture exciting. Through demonstration and hands-on learning, participants will select methods and materials that are best for them and their students. Whether participants are teaching elementary art or high school sculpture, this course will expose them to new and innovative methods to incorporate sculpture into their art curriculum in a practical and engaging way. The focus is on the unique safety precautions and best practices in classroom management, organization of materials, conceptual planning, and installation of three-dimensional artworks.
